Sealed tender is invited for hiring of office space for the following office(s) having a net carpet area mentioned below. The required office space should be located within the Municipal Corporation limits of Margao City. The tender for the required space is for an initial period of three years, which shall be reviewed from time to time.

2. As required by the Income Tax Department, the net carpet area for the office specified above should preferably be in a single independent building and preferably be on one or two floors. The place should be suitable for use as an office of the Income Tax Department and preferably be ready to be occupied with floor area for creating partitions for 07 Officer rooms, 05 Staff rooms, 01 Server room, 01 Conference room, 09 Store-rooms, 04 spare rooms and basic habitable facilities such as wall painting, provision for cabling for internet & intranet, pantry, lifts, toilets [1 attached toilet for all Officer rooms and one / two sets (gents and ladies) of common area washrooms for use by Staff and Visitors]. Offer of exclusive building will be preferred. In case, exclusive building is not available within the specifications, exclusive floor will be preferred. The commercial premises should be legally free from all encumbrances. Finalization of rent shall be based on location, quality of construction and other amenities provided subject to clarification by CPWD/Local Infrastructure Committee and the final approval/sanction of the Government of India as per rules framed in this regard.

3. Interested person / party / entity can obtain the terms and conditions of the tender, proforma for requirement of Technical and Financial bid documents from office of the Addl. Commissioner of Income Tax (ReAC), Verification Unit-1(3), Mangaluru (stationed at Margao) situated on the 2nd Floor at Blessings Pioneer Commercial Complex, Opp. District & Sessions Court, Margao, Goa, on or after 27.03.2026 or from the website <https://www.incometaxkarnatakagoa.gov.in>.

TERMS & CONDITIONS TO BE FULFILLED

Income Tax Department, Margao, Goa requires office premise having approximately 8,800 to 9,000 Sq. Ft. net carpet area for official purposes. For this purpose, tenders are being invited from interested parties along with the relevant Technical and Financial bids/proposals. Buildings with the following facilities shall be given priority for the afore-said purpose:

- 1) The building should preferably be new and located within the municipal limits of Margao City.
- 2) The building should be free from all disputes and its building map/plan should be approved by all the concerned authorities.
- 3) The building should be adequately ventilated.
- 4) There should be round the clock water supply in the building.
- 5) There should be adequate space in the building premise for parking of 10 two wheelers and 04 four wheelers.
- 6) Every floor should have at least two washrooms/toilets and one attached toilet.
- 7) The building should be earthquake resistant and have adequate fire fighting measures. The staircases should be outside the building.
- 8) There should be separate rooms for generator and security staff.
- 9) All local and municipal expenses shall be borne by the landlord/owner of the premises.
- 10) The building shall be taken on rent for a period of three years from the date of agreement and thereafter its renewal shall be done on the basis of mutual agreement, and in accordance with extent guidelines on the subject.
- 11) The building should have 100% power back-up. The said power back-up system should have appropriate and standardized meter recording the use of power from it.
- 12) The sanctioned electric load of premises should be sufficient for the Air Conditioners, lightings, fans, computer systems, other equipments/ appliances, etc. required to be operated by the Income Tax Department. In case the sanctioned electric load is less than that required by the Income Tax Department, it shall be the responsibility of the owner/ lessor to get the electric load sanctioned as per the above requirement.
- 13) The building offered must be vacant, free from all encumbrances/claims and legal or other disputes etc. Documentary evidence of ownership of the building free of any encumbrance, claim and legal or other disputes should be submitted with the Technical Bid.
- 14) The legal owner will undertake to carry out annual repairs and maintenance every year.
- 15) The building where the commercial premise is located should have an elevator / lift facility with power back-up for the same.
- 16) No tender will be accepted by fax, e-mail or any other such means.
- 17) Ernest Money Deposit (EMD): The bidder will be required to furnish earnest money in rupees equivalent to 5% of the monthly rent quoted (i.e., 5% of the rate per Sq. Ft. x no. of Sq. Ft. offered on rent) of the bid in the form of a Demand Draft (DD) in favour of Zonal Accounts Office (ZAO), Central Board of Direct Taxes (CBDT), Panaji, Goa payable at Panaji. The DD towards EMD of the unsuccessful bidder(s) shall be returned within one month of finalization of tender, issuing and acceptance of offer. Without the DD for EMD, the tender shall be out rightly rejected. DD for EMD shall compulsorily have to be submitted with the Technical bid.
- 18) The building offered on rent shall should be free from any structural defects such as water seepage, cracks, etc. The 'Structural Stability Certificate' issued by approved agencies / competent authority as per norms shall be required to be produced.

- 19) Any dispute from other tenants regarding common space/lift/parking/any other utility should be solved by the owner / lessor in consultation with the Department.
- 20) The 'Occupancy Certificate' for the building issued by competent authority shall be required to produced at the time of agreement.
- 21) No advance of any nature will be paid by the Department to the owner / lessor of the building.

The above conditions may be relaxed on administrative reasons in appropriate case. The terms & conditions mentioned from Sl. No. 1 to 21 will constitute the technical specification apart from specifications as per Technical bid format.

The rent demanded per Sq. Ft. of the covered area will constitute the Financial Bid. The rent offered should be inclusive of property tax, or any other tax like GST required to be paid by the property owners. The lease deed shall be signed for a minimum period of 3 years subject to the conditions as may be prescribed by the Government from time to time.

The bidder(s) shall be required to sign of each page of the 'Terms & Conditions to be fulfilled' and submit it enclosed along with the Technical bid.

The tenders are being invited on the basis of dual bid system

- i. Technical bid: Giving complete details of the technical aspect; and
- ii. Financial bid: Mentioning the financial terms and conditions.

First, Technical bid tenders shall be shortlisted and Financial bids of only those having qualified technically would be considered and opened. Technical and Financial bids should be submitted in separate sealed envelopes. The words 'TECHNICAL BID' and 'FINANCIAL BID' should be clearly mentioned on the said envelopes. The tenders should be received in office of the Addl. Commissioner of Income Tax (ReAC), Verification Unit-1(3), Mangaluru (stationed at Margao) situated on the 2nd Floor at Blessings Pioneer Commercial Complex, Opp. District & Sessions Court, Margao, Goa on any working day till 05:00 PM on 10.04.2026. Incomplete and belated proposals shall be outrightly rejected. The Hon'ble Principal Commissioner of Income Tax, Panaji, Goa reserves the right to reject any tender or all tenders without assigning any reason.
