ORDER No. 52 OF 2022-23 Vacancy Year - 2022

Smt. Priyanshi Verma, Stenographer Grade-II who is on deputation to the ex-cadre post of Stenographer in Airports Economic Regulatory Authority of India, New Delhi is hereby granted Proforma Promotion to the grade of Stenographer Grade-I (erstwhile Stenographer Grade-II, Scale of Pay 5000-150-6000) in the Level-6 of Pay Matrix, Rs. 35400-112400 w.e.f. **01/12/2022 (F.N)** i.e. the date on which her junior promoted and reported for duty in the grade of Stenographer Grade-I.

- 2. For the purpose of F.R.22(II), the post held by Smt. Priyanshi Verma is declared as a post outside ordinary line of promotion so long as the official's senior to her and also the official's junior to her continue to officiate in the higher post of Stenographer Grade-I w.e.f. 01/12/2022 (F.N). It is certified that official's senior to her and also junior to her in the approved panel have been promoted w.e.f. 01/12/2022 (F.N).
- 3. The pay of Smt. Priyanshi Verma in her present deputation post is to be regulated in accordance with the Department of Expenditure O.M No.1/1/2008-IC dated 13.09.2008 & DOPT OM. No. 6/8/2009-Estt.(Pay II) dated 17/06/2010 as amended from time to time and will be fixed accordingly by her borrowing Department.
- 4. This promotion order is issued purely on temporary basis and an official is liable for reversion at any time without assigning any reasons, if after a review of vacancies it is found that her appointment is in excess of the vacancies available OR for any other reasons, including directions of any Court/CBDT/DoPT etc.
- 5. The promotion of the official shall be subject to decision of the Hon'ble Central Administrative Tribunal, Bengaluru Bench, Bengaluru in OA. No. 449/2021 in the case of Smt. Sudha Vs. Union of India & OA.No. 448/2021 in the case of Smt. Moni Kumari Vs. Union of India. Further, the promotion of the official(s) shall be subject to revision of the seniority, if any, consequent to directions issued by CBDT in N.R. Parmar case vide letter dated 27/05/2019 & directions issued by CBDT in K. Meghachandra Singh case vide letter dated 26/10/2021 read with DOPT's OM dated 13/08/2021 and other similar cases on matter pending, if any, in various courts (Supreme Court/High Court/CAT etc.).
- 6. The promotion shall be subject to further orders which may be passed by the Hon'ble Supreme Court in the matter related to SLP(C) No.30621/2011 and 31288/2017 & orders of litigations pending in various courts and further instructions of DOPT and/or CBDT in this regard.
- 7. The seniority of the official will be fixed as per the rules prevailing on the subject.
