ANNEXURE 'B' TERMS AND CONDITIONS

- 1. The tenderer can inspect the Scrapped Vehicles on 15.11.2021 between 11.00 AM to 01:00 PM in the office premises at Ground Floor, VIP Parking, C.R. Building, Queen's Road, Bengaluru 560 001.
- 2. The Tender forms along with terms and conditions can directly be downloaded from the website https://www.incometaxbengaluru.org
- 3. The Reserve price fixed is Rs.12,000/- per scrapped vehicle. Accordingly, it amounts to Rs.24,000/- for two scrapped vehicles. The tenderer shall submit Rs. 2,400/- i.e. Rs.1,200/- per Vehicle as security deposit by way of Demand Draft drawn in favour of the ZAO, CBDT, Bengaluru along with the tender.
- 4. The tendered amount should be written legibly in figures and words and in whole of Rupees, failing which the tenders will be rejected.
- 5. The successful tenderer should deposit the tendered amount by way of DD in favour of the ZAO, CBDT, Bengaluru before lifting the Scrapped Vehicles. The scrapped vehicles shall be lifted within 4 working days from the date of confirmation of the disposal by the Office of the Principal Chief Commissioner of Income Tax, Bengaluru. **The Security Deposit will be forfeited** in the event of the failure of the tenderer not depositing the tendered amount or not lifting of the scrapped vehicles within stipulated time. DD of unsuccessful bidders will be returned within 4 working days.
- 6. The cost of lifting of scrapped vehicles shall be borne by the tenderer. The Department takes no responsibility in this regard.
- 7. The tenderer must obtain an acknowledgement from the Department for having submitted the Tender.
- 8. The Department reserves the right to deduct any expenses, loss/claims on account of the failure of the tenderer to comply with the terms and conditions.
- 9. The successful bidder shall not be allowed to withdraw his bid, failing which his earnest money will be forfeited.
- 10. In case highest bidder fails to honour the tender terms and conditions, then the second highest bidder will be allowed to lift the scrapped vehicles at the rate of highest bidder quoted price.
- 11. No request for inspection after submission of tender will be accepted.
- 12. The entire set of documents should be submitted, and no portion be deleted/detached from the tender documents.
- 13. Postal delays will not be accepted as an excuse for late submission of tender.
- 14. The highest bid once accepted is not transferable to anyone.
- 15. In case, the bidder is a Firm/Company, the name of the Firm/Company should be indicated as the bidder. In such a case, the person appearing for the Firm/Company shall produce authorisation letter in a proper format issued from a Competent Authority of the

Firm/Company. Request to change the name of bidder in the tender after submission of the tender will not be entertained.
