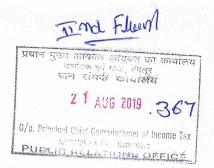

NOTICE INVITING THE TENDER FOR HIRING OF OPERATIONAL VEHICLE

The Income Tax Department intends to hire one Operational vehicle for O/o Asst. Director of Income Tax (Investigation), Kalaburagi for the period with effect from 01/09/2019 to 31/08/2021 for 24x7 hours. The open tender is invited from reputed and competent parties as per the following terms and conditions.

2. The model, colour and year of manufacture of such vehicle preferably should be as below.

- 3. Hiring of vehicle shall be initially for a period of 02 years which is extendable for another 01 year at the discretion of the Department, subject to the satisfactory services by the contractor. The vehicle will run 2000 km per month.
- 4. Tender forms along with terms & conditions can be obtained on any working days from 16.08.2019 to 22.08.2019 from the Office of the Asst. Director of Income Tax, Room No. 305, Aayakar Bhavan, Kalaburagi on payment of Rs.100/- (Non-Refundable) through Non Tax Receipt Portal as non registered users. Last date for submission of completed bids in a sealed envelope is 23.08.2019 before 03.00 p.m. in the office of the Asst. Director of Income Tax, Room No. 305, Aayakar Bhavan, Kalaburagi either by speed post/ registered post or in person. The sealed tenders will be opened on 28.08.2019 at 4.30 p.m. in the office of the Joint Director of Income Tax (Investigation), CR Builidng (Annexe), Navanagar, Hubballi.
- 5. All bidders are required to strictly comply with the specifications as instructed in Section –III and Annexure- I & II (will be provided with the tender form).

- 6. In case the Tender Committee does not get suitable quotes, then it shall be free to invite others/ local vendors considering the essential nature of requirement within the overall financial limits prescribed by the Competent Authority.

SECTION-III (FEE DETAILS) INSTRUCTION TO BIDDERS

- 1. No alteration should be made in any of the terms and conditions of the bid document by scoring out any part thereof.
- 2. Maximum amount quoted should not exceed Rs. 50,000/- per month per vehicle including of service tax and other Govt. levies as applicable from time to time.
- 3. In the submitted bid, no variation or deviations in any manner whatsoever, to the terms and conditions will be admissible. Bids not accepting or modifying any of the terms and conditions, in whole or in part as listed in Section-IV, will be summarily rejected.
- 4. Tender forms cost is Rs. 100/- (Non Refundable) through Non Tax Receipt Portal as non registered users. The procedure for payment is —> Open the portal Click search on purpose menu —> Select CBDT in the Ministry option and ZAO Bangalore—> Select tender form fee in the purpose option—> Click search and select the option appropriate in the Drawing & Disbursing Office (DDO) option—> Select 358305-Administrative officer and DDO Office of Principal CIT Gulbarga—> Inter amount and in Remarks column enter the purpose of payment —> Press Add option and then click next option —> Enter personal particulars and then make online payment. Take print out of payment receipt.
- 5. A sum of Rs.10,000/- as Earnest Money Deposit (EMD) through a banker's Cheque/ Demand Draft in favour of the Pr. Director of Income Tax (Inv.), Panaji must accompany the bid without which the bid will be rejected. The said amount will be forfeited, if the successful bidder fails within the time fixed by the Hirer, to sign the contract on terms contained in the bid document, or fails to execute the order within the stipulated time. The earnest money of the successful bidder will be refunded after signing the contract. For other bidders, the Earnest Money instrument will be returned within 15 days of the completion of bid evaluation. No interest will be payable on this deposit.
- 6. No bid will be considered unless the bid is made for supplying vehicle of the prescribed make and model for at least two years. Any bid for supply of the vehicle for duration less than two years will not be considered.
- 7. No bid will be considered unless and until all the pages/documents comprising the bid are properly signed and stamped by the persons authorized to do so on behalf of the bidder.
- 8. The bid shall remain valid for 30 days from the date of opening of the bids.
- 9. The bidder whose bid is accepted by the Hirer shall be the successful bidder. In the event of bid being accepted, the quotations (Annexure-2) and the Terms and Conditions (Section IV) will be converted into a contract, which will be governed by the terms and conditions given in the bid document.

- 10. Completed tender documents along with EMD and supporting documents in SEALED cover super scribed "*Tender for hiring of Operational Vehicle for Office of the Asst. Director of Income Tax (Inv.), Kalaburagi*" should reach the office of the Asst. Director of Income Tax(Inv.), Room No. 305, Aayakar Bhavan, SedamRoad, Kalaburagi 585 105" before the due date. Late bids will not be entertained and will remain unopened.
- 11. The bid document of every bidder shall consist of the following documents:
