The material shall be manufactured as per the relevant standards.

No bid is allowed to be modified after the date of deadline for submission of bids.

### 1. ACCEPTANCE OF TENDER: -

a) The corporation is not bound to accept the lowest tender. It reserves the right to accept any individual items from a tender or to reject any or all quotations or part of the quotations without assigning any reasons.

#### 2. PRICES:

# 3. ACCEPTANCE OF THE LETTER OF AWARD/ PURCHASE ORDER:

#### 4.AGREEMENT:

### 6. FORCE MAJEURE CLAUSE: -

If at any time during the continuation of the contract, the performance in whole or in part or any obligation under this contract shall be prevented of delayed by reason of act of god such as war, fire, flood, earthquake, acts of Civil Commotion, acts of Govt. etc., (herein after referred to as eventuality), then provided not in writing of such happenings of eventuality is given, within 15 days of occurrence thereof either party shall on the reason of such eventuality can terminate this contract without have any claim for damage against the other in respect of nonperformance or delay in performance of the contract, provided such occurrence of eventuality has prevented or delayed the execution / performance of contract for a period exceeding 60 days.

Tenders with arbitration clause will not be accepted.

# QUALITY, MATERIAL AND WORKMANSHIP:

a) All the material shall be of best quality and of class suitable for construction of the equipment and shall withstand normal variation of the temperature, payload conditions, without disturbance and deterioration or setting up of undue stresses in any part and also without effecting the strength and suitability of the various parts of the equipment for the outdoor work which they have to perform. The material shall be manufactured as per the relevant standards.

# The scope of work, terms & conditions are as under:

### 1. SCOPE OF WORK:

The scope of work shall be construction, Laying, testing of Sewerage Net Work & Allied Civil Works as per the drawings, specifications provided by us and as per the scope of work discussed during physical inspection of the site and work modulations.

# 2. CONTRACT PRICE AND ITEM RATES:

Schedule of quantities & rates for various items shall be applicable as mentioned in the work order.

Rates are inclusive of all taxes including works Service Tax contract tax, duties, royalties etc. as mentioned in the Tender document. The Final price will be calculated on the basis of actual work executed based on the item rates mentioned in the Schedule of quantities and rates. Rates are inclusive of all materials, machinery and manpower excluding cost of free issue material (Cement, Reinforcement Steel & GSW pipes).

## 3. TIME LIMIT AND PENALTY:

Entire civil work shall be completed in all respects within 01 month from the date of receipt of work order at your end. Penalty shall be applicable as per tender terms & condition.

# 4. QUANTITY VARIATION, ESCALATION IN PRICES AND EXTRA ITEMS:

Quantities of items mentioned in BOQ are only indicative and may vary by **04** 

+/- 30 % but rates negotiated and committed by you shall remain firm till the entire execution of work and in no case any escalation shall be allowed for any variation in quantities. Even some items may get deleted and variation may go beyond +/- 30%. Claim of extra items on whatsoever ground shall not be entertained.

#### 5. PAYMENT TERMS:

Payment will be released within 21 days after submission of the bill after certification of bill by engineer in charge. Final bill paymeth shall be paid within 30 days after Engineer<sup>1</sup>s certification.

#### 6. MATERIAL SUPPLY

- 6.1 The following materials shall be issued @ free of cost within a lead of 100 M. The transportation of the same within a 100 M shall be in the scope of the bidder and no extra payment shall be paid towards this.
  - (a) Cement
  - (b) TMT Reinforcement Steel if required.
  - (c) GSW Pipes
  - (d) Hem/Jute
  - (e) Bricks
  - (f) RCC Pipe
  - (a) SFRC Manhole frame & cover
  - (h) Water for Leak testing.
  - (i) Sand
  - (i) Metal -20 & 10 down.
  - (k) Water for construction as well as curing, provided contractor has to place 4 M3 capacities MS Tank or any alternatives of 4 m3 capacity tank at site.

For above material internal shifting, loading and unloading is in the scope of work contractor.

### 7. SITE OFFICE, GODOWN and LABOUR CAMP:

Contractor has to arrange.

#### 8. ALLOWABLE WASTAGE LIMIT:

- (a) Cement: +/- 1 % wastage
- (b) Reinforcement Steel bars: 3 % including rolling margin
- (c) GSW Pipes: 1% including breakages.
- (d) Sand, Stone: 5% including bulk age.

### 9. SAFETY RULES & LABOUR LAWS

- 10.1 The contractor shall strictly abide by the rules and regulations of Security & Safety enforced by us. The contractor shall take all necessary precaution to provide safety & prevent accident on the site to both personnel and property.
- 10.2 The contractor shall arrange labour license and comply with provisions of all labour laws in general and in specific, provisions of factories act, Minimum wages act, PF rules for workmen/Employees, Payment of wages, payment of bonus, workmen compensation act, safety rules etc., and extend all benefits available therein to your employees. In case of any breach from the contractor, he shall be solely responsible to make good and any loss directly or indirectly being caused to the management by your lapse.
- 10.3 The contractor shall maintain daily attendance register of the employees
- & verify the same at our labour office for minimum wages payment & PF deduction as per Govt. rules.
- 10.4 All the workmen who will be working at height/depth must wear safety

helmet, safety belts and follow instructions of our Engineer in-charge & safety Officer. The contractor shall provide all required safety materials such as helmets, safety belts, etc. at his own cost.

## 11. HYDRAULIC TESTING:

The contractor shall be fully responsible for successful necessary hydraulic testing (as specified in tender) to be carrried out by the contractor, failing which, the payments shall be withheld 10% against Laying of SWP (item no -6) & RCC Pipe (Item no 7) item till it is approved by client/consultant. The rates are inclusive of Hydraulic Testing and no extra charges of whatsoever nature shall be paid extra, however water required for the same shall be supplied by free of cost, provided contractor has to arrange 4 M3 capacity moveable receiving tank.

## 12. DAMAGES TO SERVICES & OTHER PROPERITIES:

The contractor has to agree upon to bear 1% cost of Work order Value against any type of breakages /damages to existing various services/utilities such as water supply line, electrical cables, and telephone cables, temp. Drainage (sewer/storm), etc, during any activity

as per the stipulated item mention in W.O. Also the contractor shall attend the same on immediate effect at his own cost within agreed percentage

of work. The entire job will be certified by Site in Charge for further payment verification & compliance.
