# TENDER OF HIRING OF TWO STAFF CARS& TWO OPERATIONAL VEHICALS

Two number of Staff Cars (1.Toyota Innova Crysta/2.Maruti Suzuki Ciaz/3. Maruti Suzuki Ertiga in this order of preference) and Two Operational vehicles (1.Toyota Innova Crysta/2.Maruti Suzuki Ciaz/3. Maruti Suzuki Ertiga in this order of preference) are required on monthly hire basis to be used by the O/o Commissioner of Income Tax (LTU), Bengaluru. The vehicles should be air conditioned. The quotation should be made considering that vehicles will run upto 1500 kms per month. For extra mileage the tenderer must quote per kilometer charges separately. The hiring shall be for a period of 24 months from the date of enteringinto contract and extendable by another 12 months at the discretion of the Commissioner of Income Tax (LTU), Bengaluru.

Tender forms along with terms and conditions etc can be obtained from the Office of the Administrative Officer, Gr.III, O/o Commissioner of Income Tax (LTU.), Bengaluru, Room No.721, 7<sup>th</sup> Floor, BMTC Building, 80ft Road, Bengaluru -560095 from 19/03/2020 to 24/03/2020 on any working day, between 10.30 am to 4 PM. The same can be obtained on payment of **Rs 500/-(Five hundred only)** which is non-refundable, by Demand Draft, drawn in favour of ZAO, Bengaluru and payable at Bangalore.

- 8. It shall be the responsibility of the successful bidder to ensure that, the drivers are qualified and experienced, possessing valid driving license.
- 9. The driver of the vehicle must follow all traffic rules/ regulations and any consequences of the failure to do so shall be of the successful bidder alone. The Hirer shall have no direct or indirect liability arising out of negligent / rash driving and any loss caused to the Hirer will have to be suitably compensated for by the successful bidder.
- 10. The vehicle will be hired on calendar month basis. The rate should not exceed Rs. 50,000/- for each vehicle (exclusive ofGST) for 1500 Kms (312hrs per month) on a monthly basis. The billing for Kms and hours shall be made from the reporting place to the reliving place. The vehicle must be available at any time of any day as directed by the Hirer. The operational vehicle may have to be arranged even at short notice. The vehicle will mostly be used in Bangalore but the same can also be used for travel outside Bangalore within the State of Karnataka.
- 11. Charges for additional hour beyond 312 hours per month and additional Kilometre beyond 1500 Kms per month should be quoted separately as provided in Annexure- 2 of the Bid document.
- 12. The vehicle shall be deemed to be at the disposal of Income Tax Department for all the days of the month, seven days a week. A daily record indicating mileage for each vehicle on duty shall be maintained in a log sheet as per the proforma approved by the Hirer. It shall be the duty of the driver to obtain on each day the signature of the officer to whom the vehicle has been assigned. The Log sheet shall be made available for periodic Inspection of the Hirer from time to time. Bills for payment should enclose the log sheet maintained during the month.
- 13. The hirer will pay only fixed monthly hire charges as per contract and its liability shall be limited to this value alone. No separate payment will be made for driver's salary or any other incidental expenditure such as fuel, repair, maintenance, taxes, registration charges, periodical servicing etc. All payments /expenditure will be borne entirely by the successful bidder.

The billing will be on a monthly basis and the bills typed in triplicate shall be still be still be still be still be still be billing shall be based on logbook entries.

- 22. The engagement /employment of drivers and payment of remuneration to them as per the provisions of various applicable labour laws /regulations will be the sole responsibility of the successful bidder.
- 23. A tenderer which hasbeen blacklisted by any Government Authority/PSU for the time being, will be debarred from participating in tender.
- 24. The driver employed along with the vehicles by the contractor should satisfy the following conditions:
  - Drivers should wear the prescribed white uniform. Drivers should be provided with mobile phone.
  - Once a driver has been allotted to a particular vehicle, he should remain with the same vehicle for the entire period. Any change in the designated driver should be intimated to the officer concerned at least12 hours before such change is affected.
  - Drivers should speak decent language, should be well behaved and should not have any criminal cases against them and also should not have past history of accidents. The antecedents should be duly verified by police authorities at the instance of the contractor.
  - Besides the local language, the drivers should have basic working knowledge of English.
  - Cars should be kept clean, odour free and suitable for office use.
- 25. The bidder needs to provide earnest money deposit (EMD) of Rs 30,000/-. The earnest money will be returned to the unsuccessful bidder after opening the bids. In the case of successful bidder the EMD will be retained and returned once the contract is signed by it. The same will however be forfeited in case the successful bidder fails to enter into contract.

26. In case of any dispute, the jurisdiction of courts of Bengaluru shall apply.
